OBJECTIVE

The Global Water Equities Portfolio seeks to provide reasonable and consistent investment returns, by conforming to reasonable standards of diversification and low volatility while accepting a level of risk consistent with the preservation of the Trust's assets.

Redemptions of units will be made at a price that may be more or less than the original price paid.

An investment in this fixed portfolio should be made with an understanding of the risks involved with owning common stocks and the additional risks of investing in the utility sector. The Trust is concentrated in the utility sector. Companies involved in this industry must contend with the following: fluctuating consumer demand, energy conservation, the imposition of rate caps, the difficulty of the capital market in absorbing utility debt, competition, price and supply fluctuations, international politics, interest rate fluctuations, taxes and government regulation or deregulation. Increasing sensitivity to environmental concerns will likely pose serious challenges to the industry over the coming decade.

The Trust is also concentrated in stocks issued by companies in the industrials sector. A concentration makes the trust subject to more risk. Such risks include, but are not limited to: the profitability of industrial companies will be affected by various factors including the general state of the economy, intense competition, domestic and international politics, excess capacity and spending trends.

The Trust's investment in foreign stocks also presents additional risk. Foreign risk is the risk that foreign stocks will be more volatile than U.S. stocks due to such factors as adverse economic, currency, political, social or regulatory developments in a country, including government seizure of assets, excessive taxation, limitations on the use or transfer of assets, the lack of liquidity or regulatory controls or differing legal and/or accounting standards.

The Trust also contains small-capitalization companies. There are certain risks associated with trusts that hold small-capitalization or start-up companies that have recently begun operations. Small-cap and start-up companies present risks beyond those of large-cap companies. Small-cap stock prices can be volatile.

FIVE MAJOR INFLUENCES

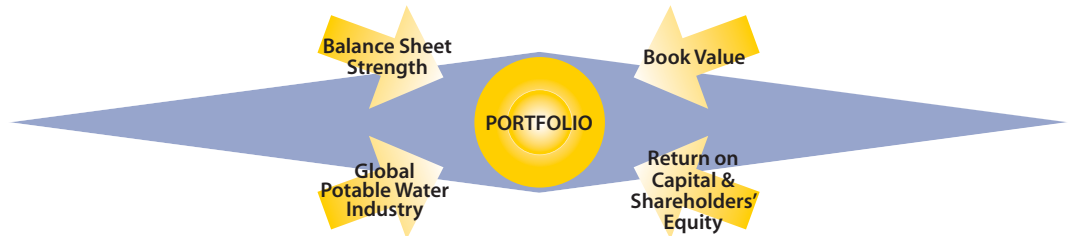
Boenning & Scattergood sees at least five major influences that should drive growth in global water companies.

- The rapidly accelerating pace of consolidation in the water industry itself.

In light of these trends, water is arguably one of the most undervalued commodities on the market today. The water industry is considered recession resistant, predictable and profitable for the growing capitalization base of the public companies involved in this industry. The Global Water Equities Portfolio was formed to take advantage of these unique investment characteristics.
